## DIRECTIONS

Read entire label before using. Use only as directed.

Ensure work area is well-ventilated during mixing and until surface is dry. Keep children and pets out of the area until foot traffic resumes.

1. Use DuPont™ Stain Protecting Grout Additive instead of water when preparing grout.
2. Prepare grout according to the grout manufacturer's recommended mixing instructions using a grout trowel or low speed mixer to achieve the appropriate grout consistency.
3. Allow the grout to stand for 10 minutes, re-mix before application.
4. Apply grout in accordance with the grout manufacturer's recommended application instructions.
5. Foot traffic on grout surfaces may begin 24 hours after installation. Protect grout from water immersion or freezing for 10 days, or per grout manufacturer's instructions, whichever is longer.

## STORAGE AND HANDLING INSTRUCTIONS

**CAUTION: MAY BE HARMFUL IF SWALLOWED. MAY CAUSE EYE, SKIN AND RESPIRATORY IRRITATION.** Do not spray. Do not ingest. Avoid contact with eyes and skin. Avoid prolonged exposure to vapors. Use only in a well-ventilated area. **KEEP OUT OF REACH OF CHILDREN.** Do not freeze or store above 100°F/38°C. Do not mix with other chemicals. Do not release into natural waterways.

## EMERGENCY/FIRST AID PROCEDURES

**Eye Contact:** Flush thoroughly with water for at least 15 minutes. Call a physician if eye irritation persists.

**Skin Contact:** Wash skin with mild soap and water. Call a physician if skin irritation persists. Launder affected clothing before re-wearing.

**Inhalation:** Move to fresh air. Call a physician if respiratory irritation persists.
